I. CALL TO ORDER

VI. PUBLIC DISCUSSION

Patricia Carter of the Oakman Blvd. Community Association provided a list of missing poles and lights out and shared that her association worked with Focus Hope, and Boston Edison Association.

Josh Elliott, Jefferson-East Business Association and East Jefferson Corridor Collaborative. Several months ago Beau Taylor from the Mayor's Office mentioned that they had a company putting up a free trial solar-powered street light. National LED Solutions and invited everyone present out



to JAZZ'N ON JEFFERSON the following week to observe the lighting.

Ken Shapiro of Consultant Engineering Associates stated that DTE has very little experience in street lighting in the City of Detroit. Mr. Shapiro also stated, that it was not a foregone conclusion that DTE is going to provide the power for the street lights. But power could be purchased from Ontario Hydro, if you want; and it could be bought from anyone who's on the grid. So that's where a potential conflict of interest might be.

Richard Tenney of the Public Lighting Department City of Detroit shared with the Board that the Public Lighting Department:

- Was kind of in a limbo-like situation; because it's quite possible that the lights they want installed are outside of where the PLA plan is;
- as a result, they were holding off on doing things;
- trying to fix all the existing lights, but not looking at putting new lights out until your plan is officially approved and in place.
- on any given day we have roughly nine crews working.
- We had no vehicles on the road for the re-lamping- in the second week of May all of the trucks went down pretty much in three days, and it took three-and-a-half weeks to get the trucks back on the road.
- He was not aware of any parts that were unavailable for any of the lighting fixtures
