### DISCUSSION

## **Project Update – Mukesh Patel and Eric Janness**

- Mukesh Patel and Joseph Stinolis presented a construction and engineering update.
- To date, more than 53,000 new LED lights have been installed with a targeted construction completion date of December 2016.
- The Lodge Service Drive is to be completed before the end of December, 2015. Lights along the service drive have been out since 2005. Construction to include new poles and lights. Service drives along I-94, I-96 and I-75 are in pre-flight finishing with the Davison Freeway. Construction to begin in 2016.
- Thoroughfare construction is underway, ahead of schedule. Jefferson Avenue, which did not have lights in areas for over five years, expected to be completed December 2016. Construction also underway on Grand River, Fort Street, Gratiot Avenue and Michigan Avenue.
- Tree trimming has been scaled back providing "tender trimming" customized for individual tree as needed.

# Smart Grid Technology - Mukesh Patel & Sandra Hughes O'Brien

- Mukesh Patel presented to technology and capabilities available of Smart Grid Technology and the benefits the technology offers the City and citizens of Detroit.
- System consists of nodes that are easily installed with new photo cell.
- Benefits include reduced energy cost (dimming options), streamline lighting maintenance (alerting PLA when lights are out).
- The system can be added to and offer billable services to municipalities and private industry.
